Ban on Single Use Plastic

Single use plastics or disposable plastics are hazardous to the nature as it is near to impossible to collect and recycle these plastic items. In this regard, the Ministry of Environment, Forest, and Climate Change prohibits the manufacture, import, and sale of 19 plastic items from 1st July 2022. Further, the Ministry also directed to increase the thickness of plastic carry bags to 120 microns which effected from 31st December 2022.
