Union Budget Highlights 2023-24

The Union Budget for FY 2023-24 was presented by the Finance Minister on 2nd February 2023. The budget session saw a number of proposals and changes aimed at improving the ease of doing business in India, promoting the digital economy and supporting the financial sector. Direct tax proposals include changes in the threshold for availing benefits of presumptive taxation scheme, deductions for MSMEs, start-ups, and other tax benefits. Changes in indirect tax, particularly goods and service tax, include simplification of the GST return filing process and increased minimum thresholds for prosecution under GST. The budget also proposed various initiatives to digitize business processes and simplify

the KYC process for digital payments. To encourage R&D in the pharmaceutical sector, specific priority areas have been identified, and facilities are to be made available in select ICMR Labs. Coastal shipping has also been promoted as an energy-efficient and cost-effective mode of transport.
