MCA notifies Amendments to the Companies (Incorporation) Rules, 2014



Environment Ministry eliminates the requirement to publish details of supply/orders on the website of Genset and Genset Engine manufacturers




CBIC amends Central Goods and Services Tax Rules, 2017; notifies withdrawal of physical verification of principal place of business in presence of applicant



Karnataka Legislative Assembly notifies the Factories (Karnataka Amendment) Act, 2023: Daily work hours allowed to be increased from existing 9 hrs upto 12 hrs subject to maximum of 48 hrs in a week



Bill introduced to amend the Maharashtra Shops and Establishment Act, 2017; proposes to include provision granting additional leave to female employees during menstrual period



Taxpayers having an aggregate turnover of up to INR 2 crore has been exempt from furnishing of Annual Return for F.Y. 2022-23 under GST
