Whereas, to put in place preventive and mitigation measures, to identify and take more stringent steps including rigorous contact tracing, testing, quarantine and isolation and any other forms of containment in the interest of health of the general public against any possible spread of COVID-19 in Shillong and East Khasi Hills District, by way of ensuring due compliance and observance of strict norms and protocols of the Advisories and SOPs issued by Government of Meghalaya in the Health & Family Welfare Department;

Now, therefore, I Smti. M. War Nongbri, IAS, District Magistrate, East Khasi Hills District, Shillong in exercise of the powers conferred upon me under section 144 Cr. P.C. read together with Regulation 3 of the Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020 do hereby promulgate <u>TOTAL CURFEW in all of SHILLONG URBAN AGGLOMERATION AND ITS ADJOINING AREAS with effect from MIDNIGHT of the 26<sup>th</sup> of July, 2020 till MIDNIGHT of the 29<sup>th</sup> of July, 2020:-</u>

### AREAS TO BE UNDER CURFEW:

- Whole of Municipal Area
- 2. Whole of Centonment Area
- 3. All Census towns areas under Mawlai Block
- 4. All Census towns areas under Mawpat Block
- Areas under Mylliem Block from Umshyrpi Bridge upto 7th Mile, Upper Shillong.
- 6. Madanrting, Mawblei, Laitkor, Nongkseh, Umlyngka, Lawsohtun and Mawdiangdiang.

### This Order will Not apply to: -
