NOTIFICATION

F.No. 47/Policy/06/2020: In exercise of powers conferred by section 127 of the Delhi Cooperative Societies Act, 2003 (Delhi Act 3 of 2004), the Lieutenant Governor of National Capital Territory of Delhi keeping in view various guidelines and restrictions which remained/remain in force on account of Covid-19 situation: hereby order that the provisions relating to the conduct of Annual General Body Meeting for the year, as prescribed in Section 31 of the Act and returns to be filed to the Registrar after Annual General Body Meeting by a cooperative society as provided under Section 32 of the Act, shall apply with following modification:-

"Every Cooperative Society shall by 31st December, 2020, call a general body meeting of its members as laid down under Section 31 of Delhi Co-operative Societies Act, 2003 and the words in Section 31(1) of the Act 'within a period of one hundred and eighty days next after the date fixed for making up its accounts for the year under the rules for the time being in force and words in Section 31(2) of the Act 'within the aforesaid period of one hundred and eighty days' would be read as 'by 31st December, 2020'."

NOTIFICATION

F.No. 47/Policy/06/2020: In exercise of powers conferred by Rule 163 of Delhi Co-operative Societies Rules, 2007, the Lieutenant Governor of National Capital Territory of Delhi keeping in view various guidelines and restrictions which remained/remain in force on account of Covid-19 situation: hereby exempts all co-operative societies which could not convene the prescribed meetings of the committee during the period from 1st March, 2020 to 15th June, 2020, from the provisions of Sub Rule (2) of Rule 60 of Delhi Co-operative Societies Rules, 2007 and further order that the provisions relating to meetings of the committee as provided for in Rule 60 (1), (3) & (4) of Delhi Co-operative Societies Rules, 2007 shall apply to all the cooperative societies registered under the Act with following modification:-

"During the period from 16th June, 2020 to 15th November, 2020, the committee of a cooperative society is also permitted to convene the meeting and pass resolution either by video conference or by circulation or through e-mail subject to giving of notice to each member through e-mail at least Five days prior to the date of meeting. In case of an emergent meeting, the service of notice through email shall be made at least Twenty Four Hours prior to the time of meeting and each member of the committee shall also be notified through telephonic call. The draft of Minutes of the Meeting convened in such a manner shall be circulated to all the members through email and if there is any dissent note from any of the members the same shall be incorporated in the Minutes and a print out of the same that shall be pasted in the book for the purpose and a copy of the final minutes after incorporating the dissent note if any, shall also be forwarded to each member of the Committee."


