### **ORDER**

In partial modification of the earlier order No. 626/Res/dt. 6.5.2020 of Collector & District Magistrate, Jajpur, it is hereby ordered that the opening of the shops registered under Odisha shops & Commercial Establishments Act. 1956 in the district of Jajpur shall be permitted from 7.00AM to 1.00 PM and 3 PM to 6.00 PM daily except those specifically mentioned otherwise by adhering to social distancing, wearing of masks and other protocols issued by Government from time to time & except in shut down areas i.e. in containment zones declared from time to time. Night curfew shall remain to be in force from 7PM to 7AM until further order.

## Shops to be opened.

- 2. Grocery, Bakery, Bread / essential consumption items including personal hygiene
- 3. Vegetable
- Non-Veg (Wednesday, Friday, Sunday)
- 5. Livestock feed
- 6. Books Shops for students
- 7. LPG Gas Agency and Transportation
- 8. Agriculture equipment repair shops
- 9. Cement, Rod, Chips and House building materials
- 10. Hardware store
- 11. Electric shops selling Fans/bulbs and other items for maintenance work
- 12. Mobile recharging centers
- 13. Electronic appliances repairing shops
- 14. Automobile spare parts, service stations
- 15. Moter cycle garage
- 16. Bicycle Repairing shops
- 17. Services/Products/Processing associated with Agriculture and allied services
- 18. Fruits
- 19. Milk & Milk products shop
- 20. Permitted Dhabas on NH (24x7)
- 21. Health Institutions and Ambulance Services (24x7)
- 22. Medicines / Optical store (24x7)
- 23. Petrol pump inside Municipal /Block area (7.00 AM to 7.00 PM) / by the side of NH (24x7)

- 24. Cloth store/Readymade Garment shops
- 25. Tailoring shops
- 26. Hotels, Restaurants, Sweets/Tiffin stalls only (takeaway facilities)/Bakery
- 27. Mobile shops & electronics stores
- 28. Stationary shops
- 29. Jewelers shops
- 30. Shoe stores
- 31. Furniture shops

Other categories of Shops and Commercial Establishment not specifically mentioned above shall remain closed.

## **Advisory**

- 1. All permitted shops are encouraged to facilitate home delivery to minimize the movement of individuals outside the home.
- 2. Senior Citizens and children are advised to stay at home and not to come outside.
- 3. Motorcycle with pillion riders is not allowed.
- 4. Person having no work in the market shall remain at home
- 5. All buyers & sellers will have to wear mask mandatorily.

## **Penal Provisions:**

Any person/ entity establishments / shopkeepers violating above mentioned measures will be liable to be proceeded against as per the provisions laid down under sections 51 to 60 of the Disaster Management Act 2005 and COVID-19 Regulations 2020 besides legal action U/s 188 IPC and other legal provisions as applicable.

This order shall come into effect from 19.05.2020 7.00 AM and remain in force during the lockdown period.
