In order to curb the sale of fake vegan foods, food regulator FSSAI has come out with regulations defining what constitutes vegan foods and listed various specifications to be followed for the manufacture, sale and import of such food items. Food Safety and Standards Authority of India (FSSAI) has come out with the Food Safety and Standards (Vegan Foods) Regulations, 2022. The regulator had brought the draft regulations in September 2021. After considering objections and suggestions received from the public in respect of the draft regulations, the FSSAI has come out with the new regulations.
