BRSR – Raises the Bar for ESG disclosures in India

While profit maximization is always the key driver for companies, in recent times we notice the drift being more towards ensuring that business is done responsibly and sustainably. With mainstream ESG becoming pivotal, regulators across the world are strengthening the disclosure framework of a company's performance around environmental, social and governance parameters. In India, SEBI introduced the Business Responsibility and Sustainability Reporting (BRSR) in 2021, mandating that the top 1000 listed entities (by market capitalization) report BRSR from Financial Year 2022 – 2023 onwards. BRSR is an updated version of the erstwhile Business Responsibility Report (BRR) requiring enhanced disclosures and evidence-based data.
