The date of implementing provisions of Legal Metrology (Packaged Commodities)
Amendment Rules, 2022 stands extended to 1st September, 2023

Department of Consumer Affairs has further extended the timeline for implementing the provisions of Legal Metrology (Packaged Commodities) Amendment Rules, 2022 from 1st July 2023 to 1st September 2023.



Environment Ministry notifies amendments to Schedule III and VIII of the Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016

The Ministry of Environment, Forest and Climate Change ("Ministry") has notified the Hazardous and Other Wastes (Management and Transboundary Movement) Amendment Rules, 2023 ("Amendment") with a view to further amend the Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 ("Rules")



Agriculture Ministry gives immediate effect to Multi-Source Edible Oils Grading and Marking Rules, 2023; supersedes the Blended Edible Vegetable Oils (Grading and Marking) Rules, 1991

Ministry of Agriculture and Farmers Welfare has notified the Multi-Source Edible Oils Grading and Marking Rules, 2023 ("2023 Rules") under the provisions of the Agricultural Produce (Grading

and Marking) Act, 1937. These 2023 Rules supersede the Blended Edible Vegetable Oils (Grading and Marking) Rules, 1991 ("1991")

Rules"). The 2023 Rules have gained effect immediately.



FSSAI extends date for compliance with Recommended Dietary Allowance 2020 till 1st January, 2024

The Food Safety and Standards Authority of India ("FSSAI") has extended the last date for compliance with "Recommended Dietary Allowance ("RDA"), 2020" till 1stJanuary, 2024.


Environment Ministry eliminates the requirement to publish details of supply/orders on the website of Genset and Genset Engine manufacturers
