1. The maximum working period will be 8 hours inclusive of 30 minutes break for Lunch/Dinner/Tiffin/etc.
2. Any extra work time be compensated with overtime Charge. A worker sill not be engaged more than consecutive 6 days.
3. A break for 1(one) day will be treated 'as on duty' and the rate of non-working day will be same as on working day.
4. A worker employed by any agency (Merchant/Sardar/Contractor) normally will be working till the age of 65 years and cannot be terminated without proper reasons and intimation.
5. A register of all Labours employed be maintained by the employer and would be subjected for verification by competent authority.
6. The maximum load will not exceed 50 Kg at any point of time.
7. Head load distance will not exceed 20 meters, which may extend to 50 meters with help/aid of any mechanized tool as trolley/wheel carts etc.
8. Piece rate system be discontinued and a monthly/daily rate is to be fixed taking skill of work in consideration.

Calcutta High Court ruled that injunction against invocation of bank guarantee can be granted U/S. *9 Arbitration Act if prima facie case is made out

In this instant case, the dispute arose from a “Goods & Service Order” agreement between the Petitioner and Respondent, under which a core curing oven was to be supplied to the Respondent. The oven was to be delivered within 60 days from the date of receipt of the confirmed order and advance payment. As per the purchase order, the Respondent was obliged to pay 50% advance, against the submission of an advance bank guarantee of equal value which would be valid up to the delivery of the complete materials at the site of the Respondent. Despite the oven being ready for delivery, the Respondent failed to accept it or provide any reason for the delay, raising apprehensions that the Advance Bank Guarantee (ABG) of ₹50 lakhs furnished by the Petitioner could be unfairly invoked.

Considering the facts, the Court emphasized that while an injunction against invocation of a bank guarantee is usually not allowed, interim protection was necessary in this case to prevent irreparable harm to the Petitioner. The Court noted that the Respondent neither communicated any deficiencies in the product nor warned the Petitioner about any breach.

Therefore, the Court ordered that if the bank guarantee is invoked, the amount of ₹50 lakhs must be deposited with the Registrar, Original Side, of the High Court for a period of three months. During this period, the Petitioner was directed to initiate arbitration proceedings, and the Arbitrator would subsequently determine the final outcome of the disputed amount. Although courts generally refrain from granting injunctions against invocation of bank guarantees, the Court held that such relief may be granted when a strong prima facie case is made out.

The Petition was thus disposed of with directions safeguarding both parties' interests during the pendency of arbitration.

****Section 9 of Arbitration and Conciliation Act, 1996:***

Interim measures, etc., by Court —

[(1)] A party may, before or during arbitral proceedings or at any time after the making of the arbitral award but before it is enforced in accordance with section 36, apply to a court—

(i) for the appointment of a guardian for a minor or person of unsound mind for the purposes of arbitral proceedings; or

(ii) for an interim measure of protection in respect of any of the following matters, namely —

(a) the preservation, interim custody or sale of any goods which are the subject-matter of the arbitration agreement;

(b) securing the amount in dispute in the arbitration;

(c) the detention, preservation or inspection of any property or thing which is the subject-matter of the dispute in arbitration, or as to which any question may arise therein and authorising for any of the aforesaid purposes any person to enter upon any land or building in the possession of any party, or authorising any samples to be taken or any observation to be made, or experiment to be tried, which may be necessary or expedient for the purpose of obtaining full information or evidence;

(d) interim injunction or the appointment of a receiver;

(e) such other interim measure of protection as may appear to the Court to be just and convenient, and the Court shall have the same power for making orders as it has for the purpose of, and in relation to, any proceedings before it.

[(2) Where, before the commencement of the arbitral proceedings, a Court passes an order for any interim measure of protection under sub-section (1), the arbitral proceedings shall be commenced within a period of ninety days from the date of such order or within such further time as the Court may determine.

(3) Once the arbitral tribunal has been constituted, the Court shall not entertain an application under sub-section (1), unless the Court finds that circumstances exist which may not render the remedy provided under section 17 efficacious.]
