With its latest consultation paper, SEBI is introducing significant reforms in Secretarial Compliance Reporting, Auditor Appointments, and Related Party Transactions, all aimed at strengthening corporate governance and enhancing transparency. These changes are not going to be just regulatory updates—they signal a shift towards greater accountability, stricter
